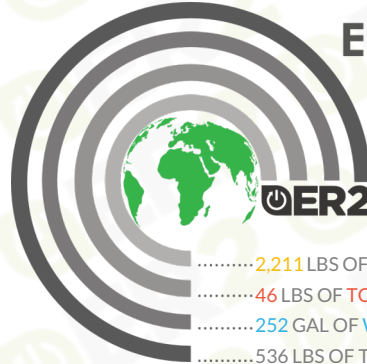

Any SSDs received will be wiped using the standard NIST 800-88 compliant hard drive wiping process unless otherwise requested by the customer.

All commodities will be sent to our approved downstream vendors that comply with the requirements of a Quality, Environmental, Health and Safety Management System and with the provisions of the Responsible Recycling Practices (R2), ISO 9001, and ISO 14001. In accordance with the corporate Environmental Policy of ER2, no material shall be sent to a landfill. Federal EPA, AZ Department of Environment Quality, and local rules, regulations and codes for the management of universal and/or hazardous waste are complied with on all shipments and handling of residual materials.
