

# **Controlled Substances Safety Checklist:**

Inventory Management Guidelines for Veterinary Practices

Changing prescription management regulations at both state and federal levels are addressing the growing opioid crisis and the necessity for veterinary practices to more heavily manage their controlled substances and narcotics inventory. But the complexity of these regulations, paired with the busy day-to-day functions of a veterinary clinic, cause many practices to overlook compliance.

Help your clinic create a more efficient and compliant process by identifying current gaps using the checklist.



#### **Common Inventory Management Challenges and Gaps**

Regulations vary state to state and the DEA has its own set of compliance standards, but there are common challenges that many veterinary practices face. Some of the most frequent gaps include:

- 1 Effectively securing controlled substances.
- 2 Unlocked safes or secure areas during practice hours.
- 3 Keeping a single drug log for Schedules I and II and Schedules III, IV and V.
- 4 Failing to reconcile drug logs with inventory.
- **5** Misinterpretation of DEA regulations.
- 6 Failing to review state laws in addition to federal standards.

### **Controlled Substances Inventory Management Checklist**

Use the following checklist to ensure best practices in the storage and reporting of your clinic's controlled substances. Managing controlled substances requires more than establishing the right protocol, the daily adherence and periodic audit are necessary.

1. Check your state and federal regulations (see page 3 for links)	1. Accurately record each drug transaction as it occurs	1. Retrain your staff on the guidelines for compliant narcotics management
2. Consult with regulatory boards, professional groups or other experts	2. Check logbooks at close of business for completeness and accuracy (if using manual books)	2. Re-evaluate your process for efficiencies
3. Implement a process that is compliant and efficient	3. Address lapses in process adherence as soon as they occur	3. Revisit state and federal regulations to make sure you're still compliant
4. Ensure double-lock security in your storage solution	4. Establish a morning inventory check in your routine	4. Evaluate the age and efficiency of the tools/ equipment you use, budget for upgrades if needed
5. Establish logs per class of drug separate from other clinic records	5. Develop an efficient rhythm for ordering and restocking to prevent shortage or unused inventory	5. Examine and reconcile logbooks to keep records up to date
6. Update hiring and onboarding processes	6. Streamline the management process by delegating duties to one individual	
7. Identify personnel authorized to access drugs
